OVERVIEW: The Automated Case Management System (ACMS) is a case management and docketing system utilized by the civil courts within the state of New Jersey. The ACMS Public Access application allows inquiry-only access to docket information for civil actions filed in Law Division Civil Part and Special Civil Part, Chancery and General Equity courts.

Enter the number that appears under the **SYSTEM** column that corresponds with **CIVIL(ACMS)** under column labeled **REMARKS / DESCRIPTION**, Press **ENTER**. You can also press the corresponding PF key for that number.

NAVIGATING IN ACMS

- PAUSE/BREAK** - Key to return to the previous screen or to log out of system
- PA1** - Return to the previous screen (toolbar)
- TAB** - Move to next field
- PF7** or **PF8** - Keys will move you forward and backwards through lists of search results, events, parties, etc.. if needed.
- SHIFT PF12 (PF24)** – Clear search criteria.

NOTE: All references in this user guide to PF Keys refer to corresponding F Keys on your keyboard. Using SHIFT + F Keys 1 thru 12 will correspond to PF Keys 13 thru 24.

NOTE: See Appendix A thru D at the end of this guide for Document, Case, Docket type codes and Venue codes used in ACMS.

Press **PF 2 PARTY INQUIRY** if you only have the party's name and no docket number.

NOTE: THE SYSTEM WILL RETURN RESULTS ON SEARCHES WITH ENTRIES OF LAST NAME ONLY.
