## ***New Motion Details***

Motions filed after 8pm Monday-Thursday or Friday 8pm through Sunday will receive a “Filed Date” of the next business day.

Previously, the Enter Motion Details section contained one mandatory question regarding an Oral Argument Request, as well as an optional question regarding inputting a Proposed Hearing/Return Date. Two additional mandatory fields will be added to this section, one question in reference to whether or not the filing is a Cross Motion, and another field where the filer will need to indicate the Proof of Service Date.

## ***Application for Wage: Update Debtor Address***

When filing an Application for Wage Execution, attorneys will now have the ability to update a debtor’s address during the filing process. From the Select Movant/Adversary screen, a Modify link will be available, where filers can update the Debtor’s address, so that it reflects accurately when the system generates the wage form.

## ***Add a Party - Defendant Address Updates***

When adding a new defendant to a DC case, if the filer inputs data into one of the address fields (eg. City field), then the system will require that all of the address fields be completed, preventing incomplete addresses from being submitted.

## ***Multi-Filing Function Update***

In the event an attorney filer attempts to submit the same filing to multiple cases, he/she will now be required to file against at least 2 docket numbers.

## ***Physical Mailing address will be populated for Not Notified Parties***

In the event eCourts can not notify a party electronically, the email notification has been updated to now include the party’s physical address for reference.
