<p>New Jersey law (<a href="#">N.J.S.A. 39:5B-29</a>) provides that the court may reduce the penalty for a <i>non-out-of-service</i> commercial motor vehicle equipment violation, if repairs are made to the vehicle. The defendant may plead guilty and submit this Certification of Repair and Plea of Guilty to the court indicated on the Complaint - Summons. <b>The defendant must attach all bills, receipts, invoices and other relevant documents associated with the equipment related repair along with a check or money order, payable to the Municipal Court, before the hearing date listed on the Complaint-Summons.
