8. **FURTHER ORDERED** that automatic termination of *pro hac vice* admission shall occur for failure to make the required annual payment of the Annual Fee and the annual payment to the New Jersey Lawyer's Assistance Fund and the New Jersey Lawyer's Fund for Client Protection. Proof of

such payment, after filing proof of the initial payment shall be name no later than February 1st of each year; and it is

9. **FURTHER ORDERED** that non-compliance with any of these requirements shall constitute grounds for removal; and it is

FURTHER ORDERED that a copy of this Order shall be served on all counsel within 3 days.
