Counsel receiving this Order through computerized electronic medium (E-Mail) shall be deemed by the Court to have received a copy of the filed Original Court document. Any document served pursuant to this Order shall be deemed to be served by mail pursuant to R.1:5-2.

These matters are hereby consolidated for discovery, case management and trial.

June 2, 2006 Plaintiff shall serve answers to interrogatories and medical reports no later than this date.

June 2, 2006 Plaintiff shall propound supplemental discovery upon defendants by this date.

June 16, 2006 Defendants shall serve answers to standard interrogatories by this date.

June 16, 2006 Defendants shall propound supplemental discovery upon plaintiff by this date.

July 7, 2006 Defendants shall serve answers to supplemental discovery by this date.

July 14, 2006 Plaintiff shall serve answers to supplemental discovery no later than this date.

August 25, 2006 Fact witness discovery must be completed by this date. Plaintiffs' counsel shall advise all defense counsel and the Special Master, in writing, if any plaintiffs are unable to be produced for a deposition and the reason for any such disability as soon as it is discovered.

September 8, 2006 Settlement demands shall be served on all counsel and the Special Master so that they are received no later than this date.

September 15, 2006 Plaintiff shall serve liability reports, if any, by this date.

September 22, 2006 Summary judgment motions shall be filed no later than this date (*a list of plaintiffs to be provided*). At least 3 weeks prior to this date, plaintiffs' counsel shall advise the Special Master whether answers to interrogatories have been served and all depositions conducted.

October 6, 2006 Summary judgment motions shall be filed no later than this date (*a list of plaintiffs to be provided*). At least 3 weeks prior to this date, plaintiffs' counsel shall advise the Special Master whether answers to interrogatories have been served and all depositions conducted.

October 20, 2006 Return date for summary judgment motions (*a list of plaintiffs to be provided*).

October 20, 2006 Defendants shall serve liability reports, if any, by this date.

November 3, 2006 Defendants shall serve medical reports, if any, by this date.

November 3, 2006 Return date for summary judgment motions (*a list of plaintiffs to be provided*).

November 15, 2006 @ 9:30am Scheduled settlement conference. All defense counsel shall appear with authority to negotiate settlement and have a representative authorized to negotiate settlement available by phone. Any requests to be excused from the settlement conference shall be made to the Special Master by 4:00pm on the date prior to the conference.

November 17, 2006 Plaintiff shall serve rebuttal liability expert reports, if any, by this date.

November 29, 2006 @ 9:30am Second scheduled settlement conference. All defense counsel shall appear with authority to negotiate settlement and have a representative authorized to negotiate settlement available by phone. Any requests to be excused from the settlement conference shall be made to the Special Master by 4:00pm on the date prior to the conference.
