# Defendant Number Must Be Entered to File on a Downgraded, Remanded or Dismissed Case

A filing on a criminal case is normally prohibited when the case is downgraded, remanded or dismissed. However, there may be mixed dispositions on a case with multiple defendants.

An update has been made to allow for filers to search for cases and submit filings for those defendants on a case for which the defendant-level disposition is <u>not</u> downgraded, remanded or dismissed, regardless of the overall status of the case.

Previously, if the overall status of a case was downgraded, remanded, or dismissed, filing was not allowed on any defendants on the case, even those who were still active and whose charges were not individually disposed of as downgraded, remanded or dismissed.

In order to file on a case with the aforementioned scenario, the defendant number of the defendant with a non-downgraded/remanded/dismissed disposition must be entered. If a search is done on a case which has an overall status of downgraded, remanded or dismissed and the defendant number is not entered, an error message will continue to display.
