### Overview

- The Expungement Portal provides an automated mechanism for a Recovery Court expungement petition to be filed, reviewed, amended, vacated and processed by various user roles.
- The petitioner chooses cases to be expunded and submits a petition/proposed order that is reviewed by the Prosecutor.
- The County Prosecutor provides a response to the proposed order and uploads their response letter; they may also return the petition/proposed order to the petitioner for review.
- Court Staff can schedule an expungement hearing manually outside the system. Moreover, they can review the complete list of cases and choose to return the petition/proposed order to the petitioner, save the final order for the judge to review, or submit an expungement decision on behalf of the judge to deny or grant the final order for expungement.
- A Judge can review the complete list of cases within the petition/proposed order and choose to return the petition/proposed order to the petitioner or submit an expungement decision to deny or grant the final order for expungement or dismiss the expungement petition/proposed order.
- The **Drug Court** expungement type has now been changed to **Recovery Court**. This change will be applicable on all newly created cases. Existing cases will still display **Drug Court** as the expungement type.
- Public Defender will be able to Amend a Granted or Amended Order Granted



#### Roles and Access

- **County Public Defenders** can access, review, and submit petitions/proposed orders created by the Central Office Public Defender or initiate and submit a petition/proposed order of their own.
- Users with this role can also make corrections to petitions returned by Prosecutors, Court Staff, or Judges.
- Users with this role can also file the following expungement types: Clean Slate, Marijuana, Marijuana Decriminalization, Regular and Amended Orders.
