5. Said attorneys cannot be designated as trial counsel.


6. No proceedings in this matter will be adjourned if said attorneys are unavailable.

8. *Pro hac vice* admission will automatically terminate for failure to make the required annual payments to the Ethics Financial Committee and the New Jersey Lawyer's Fund for Client Protection. Proof of such payment, after filing proof of the initial payment shall be made no later than February of each year.

9. Non-compliance with any of the terms of this Order shall constitute grounds for removal.

10. Service of this Order shall be deemed effectuated upon all parties upon its upload to e-Courts.
