This Matter having been assigned to the Honorable Brian R. Martinotti, J.S.C. pursuant to the Supreme Court's Order of September 13, 2010 ordering centralized case management of the Alleged Environmental Contamination of Pompton Lakes (hereinafter referred to as "Pompton Lakes") and the Court having conducted a Case Management Conference on July 12, 2011, having reviewed the proposed agenda, counsel appearing, for good cause shown and for the reasons set forth on the record.

COMPLIANCE WITH PRIOR CASE MANAGEMENT ORDER:

1. The following orders have been submitted, at the case management conference an order to amend complaints, CMO#12 was entered.
2. **B.I. Plaintiffs**, See CMO#12 and Rider attached hereto.

CASE MANAGEMENT:

1. **Lone Pine Orders.** [Defendant has requested a Lone Pine Order, Plaintiff has objected to same.] Defendant may move for the Court to issue a Lone Pine Order, this motion shall be filed on or before August 12, 2011; responses shall be filed on or before September 12, 2011, replies will be addressed at the next case management conference.

2. **Non DuPont Defendants.**

Plaintiffs' decision on prosecuting claims against the non-DuPont defendants shall be extended until September 30, 2011; Valbruna, Royale and Alrabwah time to file Answers are extended until November 21, 2011.

3. **Motion to Reinstate.**

Plaintiffs may move to reinstate the Complaints of Helen Martens (Naftali) and Barbara Honsberger (Agnes) by motion to be filed on or before August 5, 2011; responses to be filed by September 2, 2011 and replies by September 16, 2011. Oral argument, if any, will be scheduled at the next case management conference.

GENERAL:

1. The next Case Management Conference is scheduled for September 15, 2011 at 1:30 p.m. Counsel shall submit a proposed agenda 7 days prior to this Case Management Conference.

2. By consent of all parties, the court may contact or be contacted on an *ex parte* basis regarding settlement issues only.

3. The Court directs all counsel to R.1:4-8 and expects all counsel to abide by the parameters set forth therein.


4. All Court proceedings will start at the designated scheduled time. Counsel is expected to arrive promptly for these proceedings.

5. Counsel shall copy their co-counsel and all adversaries on all e-mails and other electronic correspondence submitted to the Court [COUNSEL IS PROHIBITED FROM FILING ANY PLEADING ELECTRONICALLY]. Any such submission received after 4:30 pm. will be deemed received at 9:00 a.m. on the next day Court is in session. Any such submission received after 4:30 p.m. on a Friday or over a weekend, will be deemed received on 9:00 a.m. on the next day Court is in session.
