SUBJ: Digital Audio Recording System (CourtSmart) – Access to Backup

Recordings – Request Form

DATE: January 3, 2011

Directive #07-10, issued August 3, 2010, promulgated a protocol, as approved by the Supreme Court, regarding the limitations on access to the secondary or backup recordings made as part of the new digital audio recording system (CourtSmart) for court proceedings that the Judiciary is in the process of implementing statewide. That protocol provided in part that any requests for access to backup recordings must be made to the Assignment Judge "in writing on a form approved by the Administrative Director." This Supplement to Directive #07-10 promulgates the approved form, captioned "Request to Obtain Audio from Backup Recording Server" (attached).
