Enclosed for immediate statewide use is a revised form Order to Produce (CN 10054), which replaces the form promulgated by Directive #01-04. The remainder of Directive #01-04 remains in effect. The court issues this Order to Produce for the production of state inmates housed in state correctional facilities, juveniles under the care of the Juvenile Justice Commission, and civilly committed sexually violent predators.
